**Carl Thomfohrda-Rural Mutual Insurance Rep:** Carl Thomfohrda provided information to the Board about changes and additions that may need to be made if there is a new Town Hall/Shop built.

**Donald Chell- County Board of Supervisors Rep:** Donald is on the Burnett County Supervisor's Public Safety Committee. Issues with S. Williams Rd and Crosstown Rd and Wood Lake Rd intersections. He stated that there was a discussion at the County level. Solar stoplights are approximately \$2,000 each- very expensive. Asked about a 4-way stop. That didn't go over very well. Rumble strips? That was sort of approved. Donald proposed the reflective and rotating sign that attaches to the top of the stop sign. They sell for \$65 each. Joel Johnson said that we will be putting in rumble strips on Crosstown Rd with Cty. Rd Y, in both directions. Also, Wood Lake Rd and S. Williams Rd intersection.

**Craig Selander:** Architect Craig Selander went over all the plans and changes that were made for the potential new Town Hall/Shop after he had met with all the Town employees.

Daryl Wedin made a motion to approve the September 2018 Treasurer's report as presented. John Hennessey seconded the motion. All voted in favor. MC

**Fire Association Report:** Daryl Wedin submitted the September 17, 2018 regular Fire Association meeting minutes for our review.

**Road Maintenance:** Jeff Erickson reported: We are keeping everything going. The grader is using more water than normal, about 1 gallon a day. It doesn't look like it is going into the oil. The mowing is all done. Have switched over to brush cutting. Garrett Leudtke is working near Webb Lake. Hopefully his crew will be back in area next week. Gravel supply needs to be bid on in February.

**Resolution to Propose Exceeding Levy Limits: Review and decide:** John Hennessey made a motion to pass the Resolution to Propose Exceeding Levy Limits on November 14, 2018. Joel Johnson seconded it. Joel Johnson and John Hennessey voted in favor. Daryl Wedin opposed. MC.

**Audit the bills:** Joel Johnson made a motion to audit the bills. John Hennessey seconded the motion. All voted in favor. Bills approved and paid. MC
